25-26/025 Public Section

25-26/027 Declarations of Interest

25-26/028 A419 Closures/Diversion Routes

A meeting was held with representatives from the Parish Council, National Highways, Wiltshire Highways and Road Management Services to discuss A419 closures, diversion routes and the effect of traffic coming through the village.

The meeting was called due to an increase in complaints being received when the A419 is closed and traffic is diverted around Ashton Keynes. Signage has also been moved into the carriageway causing an obstruction, this is a criminal offence and can cause accidents. Signage gets checked prior to all closures and any further incidents involving signs being moved will be reported to the Police.

Additional signage has been put out and bigger signage will now be put out for the remaining closures. Extra Sat Nav signage has been put out and additional advanced signs will now be put out on the Spine Road.

Any road traffic incidents should be reported to Wiltshire Police: www.wiltshire.police.uk. A Wiltshire Council Highways representative will be raising the issues with the local Highways Engineer again and making the local policing team aware of weight restriction breaches.

Sat Nav companies are taking data from sources such as one.network and are working on improving routing accuracy and avoiding suggesting unsuitable 'shortcuts' that go against signed diversion routes.

There is a planned closure Northbound from 23rd July to 4th August and then there will be no further **planned** closures for the rest of the year.

The Route Manager at National Highways is going to communicate with the Police regarding HGVs ignoring the official diversion and the weight limit restriction through the village.

Everyone is working together to try to limit traffic coming through the village

Potholes in Kent End – Email report of potholes in Kent End.

Requested Parish Steward investigate, he found no potholes, however there were builders vans parked in the road. Suggested that photos are taken when road is clear and report direct to Highways using MyWilts online reporting.

Verges in Rixon Gate – Email received asking for verges to be cut back in Rixon Gate due to poor visibility.

Contacted Highways and advised resident to report via MyWiltshire Online Reporting. Received further emails from the same complainant demanding action. Wiltshire council have sent an officer and remedial works are planned.

Overgrown Tree – Email received asking for PC assistance with a tree on a neighbouring property causing issues neighbour.

Advised that it is a civil matter and the PC cannot get involved. The PC can write to request that the overgrowing vegetation is cut back from the footpath.
